Our 2nd Vice President Janet Beavers is busy planning our July Party as we do not have a Membership Meeting in July. She will be presenting the final plans and date soon.

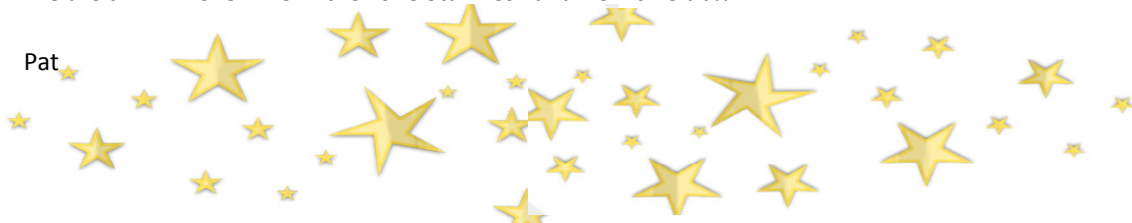

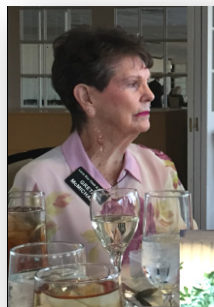
Ms. Edwards presented "Oil and Gas Finance- Post Downturn: A New Era". She gave a great discussion, along with a power point presentation, on reserves based loans (RBL). She explained that an RBL is an asset-based lending option that oil and gas companies can use to finance assets that are already in production or for production that is expected to soon begin. The repayment of the RBL comes from proceeds derived from the production. She went on to explain how her bank analyzes applications to determine the present value of future production while taking into account factors such as the location and type of reserve. Additionally, she spoke about the new government regulations that have been issued for RBLs, making it a little more difficult for some companies to obtain these loans when they are most needed.



Kristin Robertson, CEO of Brio Leadership, is a premiere company culture consultant, having worked with companies such as Hewlett-Packard, 7-Eleven, Southwest Airlines, Susan G Komen, and Schneider Electric to develop their leaders and grow vibrant organizational cultures. In addition, she is an executive coach who helps leaders sharpen their skills and inspire a shared vision, and a interactive meeting facilitator.

Field trip to Lewisville Trinity Water Treatment Plant

Friday, April 13th at 3:00

Water is just as important in our industry as in our lives. Join us on this fun and informative tour of the Lewisville Trinity Water Treatment Plant to learn more about this valuable natural resource.

Regional Treated Water Plant, Lewisville. Constructed in 1977, treating to its full 20 million gallon per day (MGD) capacity the first year of operation, this water treatment plant was expanded to 70 MGD in 2001. Plant features include:

- ✦ Ozone as a primary disinfectant resulting in improved destruction of bacteria and viruses, fewer chlorination by-products, and removal of taste and odor components from lake algae and blooms.
- ✦ Granular activated carbon is used in the filter beds to remove organic compounds, including pesticides and herbicides.
- ✦ Flocculation slows the mixing and coagulation of solid material without using electrical power.
- ✦ State-of-the-art computer systems are used to monitor transmission flows, elevations in storage facilities and customer demand levels.

Below is a typical process of how water from lakes is treated and distributed to cities and utilities and then on to local residents and homeowners.

New giant created in \$9.5B deal for Dallas' RSP Permian

Midland's Concho Resources has agreed to acquire Dallas oil and gas producer RSP Permian in a \$9.5 billion deal that will forge a new giant in the busy West Texas fields.

The acquisition comes as more drillers are getting back to work to chase oil prices that have stabilized above \$60 per barrel for much of the year, and large producers are focusing on the Permian basin. The deal also sets a benchmark for how much of a premium investors and large energy companies will have to pay for firms focused on the Permian.

Concho, which was formed in 2004, is exchanging 0.32 shares of its common stock for each share of RSP stock – representing a price tag of about \$8 billion. The company is also taking on about \$1.5 billion in RSP Permian debt, pushing higher the value of the deal.

The amount Concho is paying is a 29 percent premium on RSP shares.

Paige Marcus, an analyst with CFRA Research, estimated the deal values RSP Permian at \$80,000 per acre, which is "a substantial premium to typical Permian deals." The two companies, Marcus, said in a research note, "share some adjacent acreage in the Permian, so a combination makes a lot of sense operationally, in our view."

RSP Permian had been one of the biggest oil and gas producers based in Dallas. The company was drilling more than 55,000 barrels of oil per day as of the end of last year.

With the acquisition, Concho controls about 640,000 acres in the Permian. The combined company will operate one of the largest drilling programs in the basin with 27 rigs.

"Together our scale in the Permian basin will be powerful," Concho CEO Tim Leach said in a call with investors Wednesday.

Leach indicated on the call that the company would continue to exchange land, particularly on the New Mexico side of the Permian, to further focus its operation.

"This gives us more chips to play with," Leach said. "I think you'll see the trading activity continue."

Reports: Rex Tillerson on list of potential candidates for University of Texas System's top job

Mar 26, 2018, 8:42am CDT

Rex Tillerson is being sought by key insiders at the 14-campus University of Texas System to be chosen as its next chancellor, according to media reports that cite people familiar with the matter.

Tillerson, the former CEO of Exxon Mobil Corp. (NYSE: XOM) who was recently fired by President Donald Trump as U.S. Secretary of State, is now the favorite of some chancellors in the UT System, the Texas Tribune reports. The story was first reported by the Wall Street Journal.

Executive search firm Russell Reynolds Associates has been hired to conduct the search to replace Chancellor Bill McRaven, who announced in December he intended to step down in the spring due to health reasons. If the name of the headhunting firm sounds familiar, it's because it is the same company that helped Austin find its new city manager.

A UT System spokesman said any names being mentioned as frontrunners at this point are "speculative at best," per the Tribune.

Trump removed Tillerson from his Cabinet post on March 13 after a rocky 14-month tenure as Secretary of State and nominated CIA Director Mike Pompeo to replace him. Tillerson and Trump had grown increasingly at odds on several key policy issues, and at one point multiple reports surfaced that Tillerson had described Trump as "a moron."

Tillerson is a graduate of the University of Texas at Austin and was a member of the Longhorn band.

The UT System is based in Austin and has an annual budget of more than \$18 billion and 100,000-plus employees.

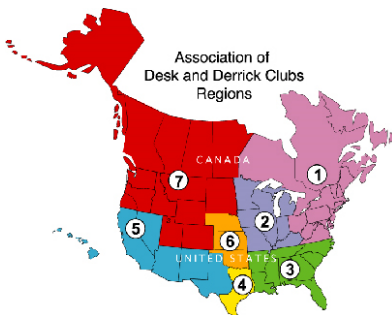

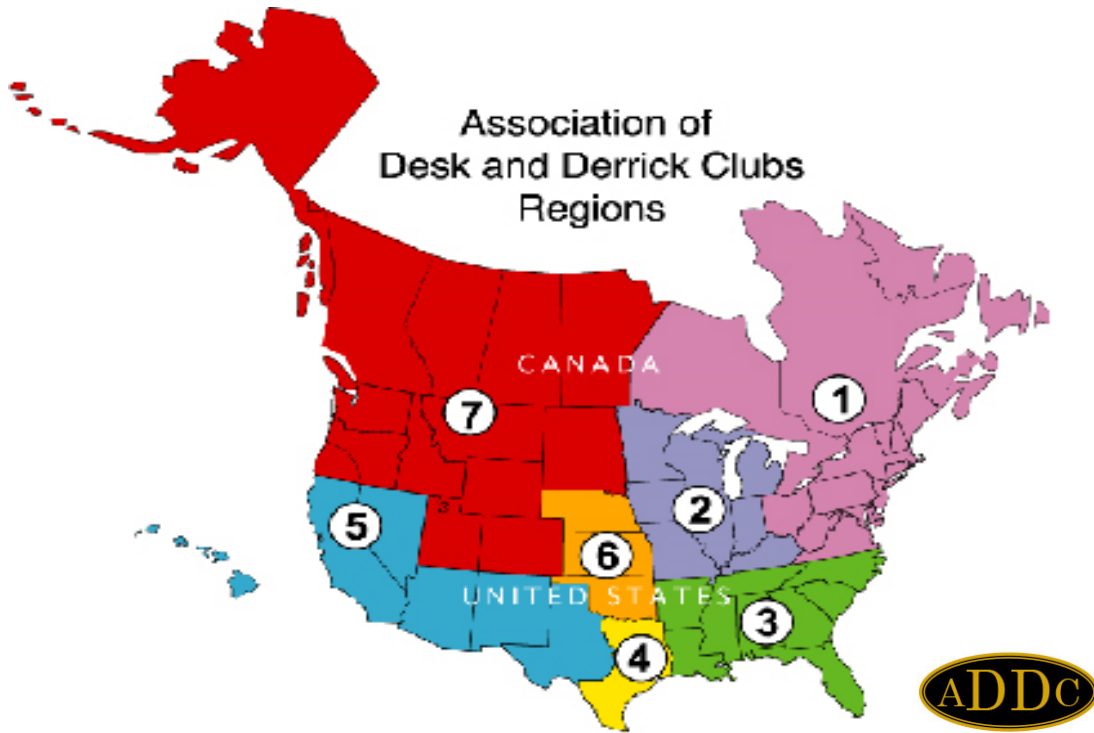

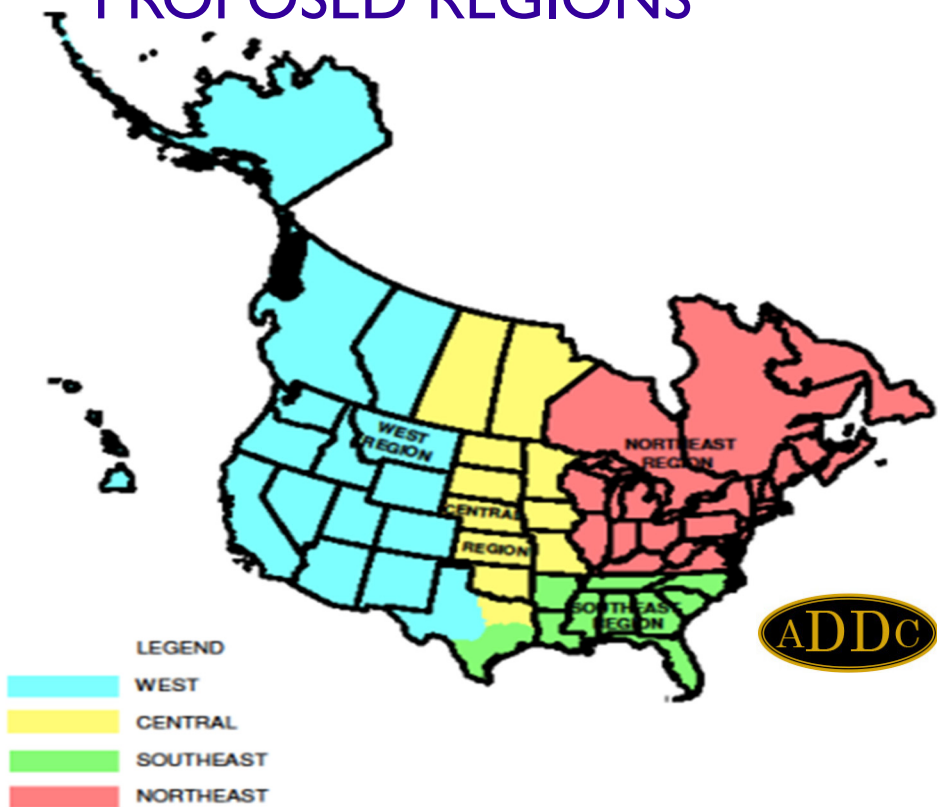

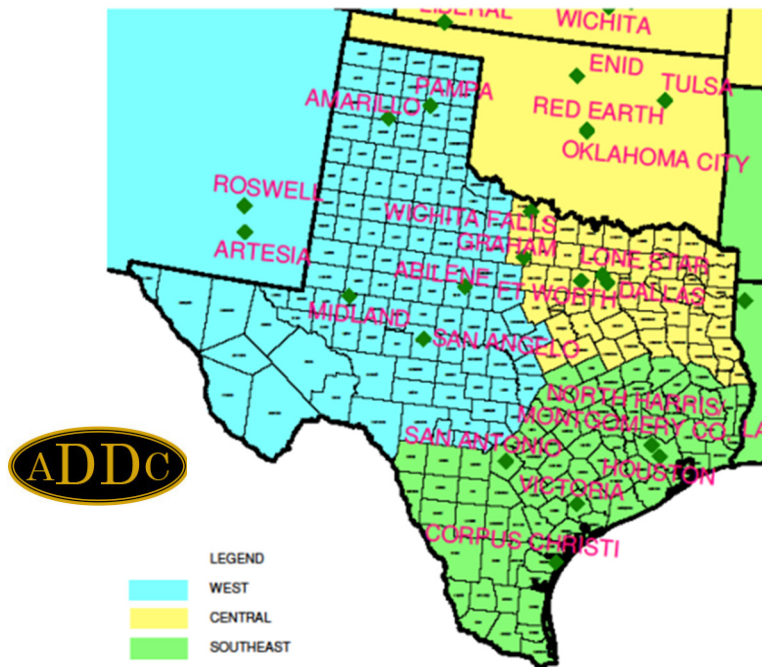
CURRENT REGIONS

A petroleum tech certificate of completion will be given to individuals who have attended and passed the comprehensive examination for the six subjects included in the curriculum at either conventions or regional meetings. Program will be 5 – 6 hours with an examination at the end of the session.

About the Speaker

Sheryl Minear has been employed in the energy industry since 1977. She began her career as the store manager for an oilfield supply company. She has worked for several operators throughout the years in accounting, land and regulatory departments. Sheryl was also employed by an Oil and Gas Accounting Software company, WolfePak, for ten years.

Sheryl joined the Association of Desk and Derrick Clubs (ADDC) in 1983. As a member of the Abilene club, she served in all offices and chaired or served on all committees. She transferred to the San Antonio Club in 2015 and is currently serving as the club's parliamentarian.

Sheryl was Region V Director in 1997 and served as the Region V Parliamentarian for several years. Sheryl obtained the status as of Registered Parliamentarian from the National Association of Parliamentarians in 2002 and served as the ADDC Parliamentarian in 2003, 2004, 2010-2017.

Sheryl is currently serving as Vice President of the Council of Petroleum Accountants Abilene Society.

Classic Deviled Eggs

Recipe courtesy of Mary Nolan

Show: Chic & Easy

Episode : Posh Picnic

Total : 35 min

Prep : 20 min

Cook : 15 min

Yield : 4 servings

Level : Easy



Ingredients

- *6 eggs
- *1/4 cup mayonnaise
- *1 teaspoon white vinegar
- *1 teaspoon yellow mustard
- *1/8 teaspoon salt
- *Freshly ground black pepper
- *Smoked Spanish paprika, for garnish



Directions

Place eggs in a single layer in a saucepan and cover with enough water that there's 1 1/2 inches of water above the eggs. Heat on high until water begins to boil, then cover, turn the heat to low, and cook for 1 minute. Remove from heat and leave covered for 14 minutes, then rinse under cold water continuously for 1 minute.

Crack egg shells and carefully peel under cool running water. Gently dry with paper towels. Slice the eggs in half lengthwise, removing yolks to a medium bowl, and placing the whites on a serving platter. Mash the yolks into a fine crumble using a fork. Add mayonnaise, vinegar, mustard, salt, and pepper, and mix well.

Evenly disperse heaping teaspoons of the yolk mixture into the egg whites. Sprinkle with paprika and serve.
