



JANUARY SPEAKER- JOHN TINTERA





John Tintera President, Texas Alliance of Energy Producers

John Tintera is a regulatory expert and licensed geologist (Texas #325) with a thorough knowledge of virtually all facets of upstream oil and gas exploration, production and transportation, including conventional and unconventional reservoirs. As a former Executive Director and 22-year veteran of the Railroad Commission of Texas (RRC), considered the premier oilfield regulator in the nation, John oversaw the entire regulatory process, from drilling permits to compliance inspections, oil spill response, pollution remediation and pipeline transportation.

John was elected President by the Board of Directors of the Texas Alliance of Energy Producers in November 2017, and took office at the beginning of 2018. The Alliance is the largest state association in the country for Independents.


Mr. Tintera has BS and MS degrees in Geology from Michigan State University and almost 30 years of combined technical and managerial experience: 11 years as an industry petroleum geologist and 18 years as a state regulator. He has an in-depth knowledge of the state and federal regulatory framework of the E&P industry, including RCRA, CERCLA, SDW Act and OPA. In addition, Mr. Tintera has a comprehensive knowledge of environmental assessment, remediation and emergency response.

John's expertise, sought in the US, has extended abroad where European governments, confronted with the recent potential of developing unconventional energy in their countries, find themselves at various stages of preparedness, given the complexity of issues. They have reached out to John to share practical ideas, technical know-how and regulatory best practices as they create and update regulatory frameworks to allow safe economic development of natural resources, mirroring what has long been underway in Texas. John also delivers papers and consults on numerous other environmental, energy and regulatory issues. John and his wife Jenna live in Austin, Texas.

DRONES IN THE OIL FIELD

What a fun and informative November presentation! John Ratcliff of Transglobal Services, LLC (TGS), delivered a talk on the usefulness of drones in the oil field. He even brought along some 'cool toys' for the club to see firsthand. John mainly focused his talk on two particular drones, the floating Hy-Drone and the aerial eBee senseFly.

The Hy-Drone is a remote controlled catamaran platform for bathymetric survey. It has many applications, but an example John used for the Oil and Gas industry was for creating a profile of a water pit. The Hy-Drone creates the profile to pin point the best location for setting up a pump. This remote device eliminates having personnel in deep and unsafe water. It is also faster than traditional methods and provides for a much more accurate profile and the best part is that there are less chances for lost equipment.

The second drone John talked about was an air drone, the eBee senseFly which is a hand-portable, remotely controlled device that produces a variety of data deliverables in the way of aerial imagery. This is extremely useful when planning oil field operations. Traditionally this would be accomplished by way of field visits with survey crew to map an area. This takes more time, more people and you still do not get imagery. The eBee senseFly Gives you the ability to plan your operations from the office. It produces safe, accurate and efficient survey data without using a large crew. It also helps complete survey operations quickly, thus saving not only time, but also money.

Greetings 2019 Presidents:

Congratulations on being elected to lead your club in 2019. I'm looking forward to working with all of you this year.

Each club faces the challenge of presenting <u>nine</u> educational programs during the year. At least <u>six</u> of the programs must be energy or energy related presentations whether it is an outside speaker or someone within the club. The other <u>three</u> programs can consist of an ADDC orientation and two socio-economic or professional self-development programs.

You may wonder why it is necessary to monitor each club's reports. The Association of Desk and Derrick Clubs (ADDC) has an exemption from paying U.S. Federal Income Tax because our primary purpose is education. To retain this tax-exempt status, each club is required to file a Program Report to verify that we comply with the tax law and our ADDC Bylaws requiring <u>nine</u> educational programs per year. The Program Reports are kept as a permanent record in case of an IRS audit.

The PROG1 (Program Report Form) will be provided to you via email, to be forwarded to the person within your club responsible for preparing and submitting the report each month. The Meeting Schedule is on the first tab; it must be completed and submitted to your Program Committee Region Representative no later than January 31, 2019.

On a monthly basis, the PROG1 form should be completed and submitted to your Program Regional Representative no later than seven days after your meeting. The Representatives will then in turn forward the form to me to complete the monthly submission to the Board contact and ADDC Webmaster. The report must be submitted each month whether you have a meeting or not; if your club doesn't have a meeting one month, simply put a check by NO MEETING. If you need help filling out this form please contact either your Representative or me.

Reality Star in Texas Poised to Become America's Richest Oil Mogul


When Autry Stephens struck out on his own in 1996 to pursue oil riches, he named his one-rig outfit Big Dog Drilling Co.

Twenty years on, the moniker seems prophetic. Stephens, 80, owns the largest closely held oil producer in Texas by production volume, Endeavor Energy Resources LP. The Midland-based firm has suitors including Exxon Mobil Corp. and Chevron Corp. weighing bids that could value the company at \$15 billion, including about \$1 billion of debt.

A sale of that magnitude would rank among the 10-biggest deals for a private energy company and make Stephens one of the world's richest people. He and his family own all of Endeavor, which controls drilling rights on 329,000 net acres in the Midland Basin, a subsection of the Permian Basin of West Texas.

While oil's drop of more than 30 percent in the past two months may deter some potential acquirers, Endeavor holds almost unparalleled opportunity for Big Oil: one of the last major land positions in private hands in the heart of the Permian Basin.

Land values in the shale-rich territory have soared as investors flocked to get a piece of the country's most-productive oil region. A sale would tap into those lofty valuations and potentially give Stephens a fortune worth as much as \$14 billion, which would rank him among the world's 100 wealthiest people, according to the Bloomberg Billionaires Index. It would also make him the richest oil mogul in the U.S., ahead of Continental Resources Inc.'s Harold Hamm and George Kaiser of Kaiser-Francis Oil Co.

Stephens, who grew up on a peanut and watermelon farm in central Texas, declined to comment on his wealth.

A chance to work in exotic locales lured him to the oil industry, according to a profile on the website of the University of Texas at Austin, his alma mater. He never took a job in Saudi Arabia or Indonesia, but he did accumulate a massive land portfolio in his home state.

After graduating with a degree in petroleum engineering, Stephens worked for Humble Oil, now part of Exxon Mobil, the Army Corps of Engineers and a local Midland bank, where, inspired by the entrepreneur clients he met, he decided in 1979 to forgo a corporate career track.

Over the following decades, he transitioned from an engineer-for-hire with little to his name to oil tycoon, buying up drilling rights and branching into various ancillary businesses such as trucking, well services and roustabout construction. He poured profits from drilling wells back into the business and used them to buy more land, according to a person close to Stephens who asked not to be identified discussing nonpublic information.

'Deadliest Catch'

Stephens, bespectacled and balding, had an unexpected brush with fame as a reality star in the truTV documentary series "Black Gold," made by the producer of "Deadliest Catch." The billionaire was a key figure in the plot of Season 2, which centered on workers on a Big Dog rig racing to finish four wells in 50 days.


The televised sweat and drama depicts just a small part of Endeavor's business. Less than 2 percent of the company's Midland Basin acreage has been developed with horizontal drilling, a technique that helped unleash record U.S. oil production. That vast potential of untapped land is a significant draw for would-be bidders, though the sheer size means the pool of buyers is limited to those with the deepest pockets. Exxon made a similar deal in 2017 when it spent about \$6 billion acquiring drilling rights from the Bass family.

The region is better placed than other shale fields such as the Eagle Ford in Texas and Bakken in North Dakota to survive the downturn, according to RS Energy Group. Its wells can make 30 percent

Exxon is the "most logical" buyer for Endeavor, given its ability to pay, focus on the Permian and history of joint ventures with Stephens, RBC Capital Markets analyst Scott Hanold said in a note to clients last month.

Exxon is the Permian's most active driller and aims to increase production from the basin to mitigate steep de-

clines elsewhere.

Exxon Chief Executive Officer Darren Woods, who declined to comment on Endeavor during a Nov. 6 interview with Bloomberg TV, said his company has the capacity to do a deal of almost any size.

"It's really a function of looking at the value that Exxon Mobil can extract and how we would integrate that into our portfolio," he said.

Still, a mountain of cash isn't necessarily what Stephens is seeking. He and his family would prefer to stage an initial public offering next year, allowing them to maintain control, according to people with knowledge of their thinking.

Near Collapse

Endeavor's valuation is also striking considering the company almost collapsed a decade ago. During the 2008 financial crisis, a group of banks spooked by liquidity concerns demanded Endeavor repay \$100 million within six months. Stephens was forced to shut down all but a few of his rigs. And that was at least his third dramatic near-bust since he started working for himself almost 40 years ago.

"The history of the oil industry is full of stories of people making and losing fortunes several times over," he said in the UT-Austin profile. "Don't let fear of failure keep you from following your dream."

SOUR CREAM CUT-OUT COOKIES FROM KITCHEN OF POLLY MAREK



COOKIES

3/4 CUP SHORTENING 3/4 TSP BAKING SODA I I/2 CUP SUGAR 3/4 TSP SALT 2 EGGS I TSP CINNAMON I TABLESPOON VANILLA 4 CUPS FLOUR I I/2 TSP BAKING POVVDER 2/3 CUP SOUR CREAM

ICING

2 LBS POWDERED SUGAR 2 TSP VANILLA 3/4 CUP SHORTENING 2 TSP ALMONG FLAVORING 1/2 CUP CAKE FLOUR 2 TSP BUTTER FLAVORING 1/2 TSP SALT 1/2 CUP WATER

Cream shortening and sugar until light and fluffy. Add eggs one at a time. Mix in vanilla, baking Powder, baking soda, salt, cinnamon and flour. (I usually add I cup of flour at a time because it mixes better). Add sour cream I wrap in saran wrap and chill for several hours (I usually freeze). Roll to $\frac{1}{4}$ inch thick (use flour to help work with the dough). I usually use metal cookie cutters. Place on ungreased cookie sheet. Bake at 375 for 12 to 14 minutes or until lightly brown

Mix all icing ingredients together. Add food coloring if desired and ice cookies Let icing "dry" before you put in containers
