

The objective is advancing the common interests of the members of professional societies serving the energy industry in Texas to achieve economies, to protect and educate the public and to promote communication and to maintain a central coordinating body to provide a forum for association and communication for representatives of several Constituent Organizations of those energy-related professions.

The Board of Directors consists of two members of each Constituent organization selected by that organization to represent their organization on the TEC Board.

## The *Fierce* NPRI

Generally speaking, a mineral owner negotiates a mineral lease, receives a bonus upon lease execution and receives their share of production in the form of a royalty, which may incur expenses related to the cost of production. The mineral owner may also have rights to delay rentals and shut-in royalties. So what exactly is a non-participating royalty interest (NPRI) and where does it fit in?

An NPRI is most often retained when the mineral interest is sold. The concept behind an NPRI is rather simple, yet, the grantor's intent and deed construction are often cause for litigation. This article will only discuss the concept of the NPRI and will not tackle construction issues. The NPRI is derived from the mineral ownership and receives its share of production free of the cost of production; however, the NPRI owner does NOT have the power to lease the mineral interest (executive right) and does NOT have rights to the lease bonus, delay rental or shut-in royalties. The NPRI is dependent upon the owner of the executive rights to negotiate an oil and gas lease that will benefit both parties. In *KCM Financial LLC v. Bradshaw*<sup>1</sup>, the Texas Supreme Court recognized the executive owner's broad discretion in negotiating mineral lease terms but also upheld that the owner of the executive rights has a duty of "utmost good faith and fair dealing" to the non-executive royalty owner. The Court stated that, at the very least, the executive owner is prohibited from engaging in acts of self-dealing that would unfairly diminish the value of the non-executive interest. By example, the court noted that negotiating a sub-market royalty for a higher bonus amount would be a factor in determining a breach of the duty.


Although, an NPRI owner cannot negotiate an oil and gas lease, the owner of the executive rights cannot contract of behalf of the NPRI owner to pool that interest. The Texas Supreme Court in *Brown v. Smith*<sup>2</sup> surmised that by reserving the royalty interest the owner contemplated future leasing for oil and gas production; however, it cannot be assumed that they would also agree to pool their interest and possibly dilute the royalty. So, in order to pool the NPRI interest, operators will seek out a Ratification from the NPRI owner. Without ratification the NPRI owner is entitled to their full royalty interest instead of the proportionate share of the pooled unit.

Due to its cost free status and power to pool, the NPRI may technically be smaller than the mineral owner, but it can still be a fierce and lucrative opportunity in the life of a producing well.

Slow Cooker Peach Cobbler

Total: 3 hr 30 min  
 Prep: 15 min  
 Cook: 3 hr 15 min  
 Yield: 4 to 6 servings  
 Level: Easy

**Ingredients**

- 6 ounces dark brown sugar
- 3 1/2 ounces rolled oats
- 4 ounces all-purpose flour
- 1/2 teaspoon baking powder
- 1/2 teaspoon freshly ground allspice
- 1/2 teaspoon freshly grated nutmeg
- 1/4 teaspoon kosher salt
- 1/4 cup unsalted butter, at room temperature, plus extra for the cooker
- 20 ounces frozen peach slices

**Directions**

Combine the sugar, oats, flour, baking powder, allspice, nutmeg and kosher salt in a large bowl. Add the butter and work into the dry ingredients until a crumbly texture is formed. Fold in the peach slices.

Butter the bottom and sides of a 3-quart cooker. Add the mixture to the slow cooker and cook on low for 3 to 3 1/2 hours. Serve immediately.
