



### John Trosclair Oilfield Christian Fellowship











Oilfield Fires was presented by Wayne Peters, Saturday, June 16, 2018 at Brookhaven Country Club, by Lone Star Desk & Derrick Club of Dallas.

Mr. Peters is a Petroleum Engineer and worked for oil and gas companies in Lafayette, Abilene, Midland and settled in Graham almost the last 40 years as a consultant. For the last 19 years he has been a Volunteer Firefighter and currently serves as Chief of the Young County Rural Volunteer Fire Dept. and Salt Creek Volunteer Fire Dept. He has taught several fire departments in North Texas and the Red River District 10 Firefighting School so he is very familiar with oilfield fires!

His presentation included what the chemical makeup of what is in tank batteries and informed us that lightening is the cause of a lot of oilfield fires. Another cause is static electricity found in aluminum pipe where lightening can strike. He showed lots of actual fire photos and videos of tank batteries struck by lightning and the fire can be so intense, it will blow the lid off a 220 barrel tank like a rocket. He said if you can't put it out in 5 minutes then just let it burn (...or call Cudd Pressure Control or Boots & Coots).

He stressed how important it is to evacuate at least ½ mile radius of the fire which means no firefighters, no bystanders or surface owners or TV cameras anywhere near the fire! LEAVE IT ALONE OR LET IT BURN! Equipment can always be replaced. Crude oil can burn upwards of 1,000 degrees!

# Texas reclaims No. 1 spot on CNBC's 'America's Top States for Business 2018'

Jul 11, 2018, 8:32am CDT

Texas landed the top spot on CNBC's "America's Top States for Business 2018", making it the first four-time winner in the 12-year study.

However, this is the first year Texas ranked No. 1 since 2012. The state has never ranked below No. 5 overall, and it took the No. 4 spot last year.

CNBC cites the long-awaited rebound in oil prices — which increased around 60 percent in the past year to the \$70-per-barrel range in June, per CNBC — as a major factor in this year's ranking. The report notes that the state added more than 350,000 jobs in the past year, with the energy sector driving the biggest increase.

Texas landed the top spot on CNBC's "America's Top States for Business 2018" and WalletHub's "2018's Best & Worst States to Start a Business."

Texas saw solid economic growth last year, especially in the fourth quarter, when state GDP increased 5.2 percent, per CNBC. That boosted Texas' rank in the

economy category to No. 1 this year, up from No. 25 last year, when oil prices were around \$40 per barrel, per CNBC.

The Lone Star State also ranked No. 1 in the infrastructure category, No. 3 in access to capital, No. 7 in workforce, No. 9 in technology and innovation and No. 11 in cost of living. The state does OK in cost of doing business and business friendliness, ranking No. 18 and No. 21, respectively. However, it comes in among the bottom half of states for quality of life (No. 31) and education (No. 37).

A similar report last week also ranked Texas No. 1.

WalletHub's "2018's Best & Worst States to Start a Business" compared the 50 states across 25 key indicators of startup success divided into three main categories. Texas came out on top overall and took the No. 1 spot in the business environment category. It ranked No. 12 for access to resources and No. 16 for business costs.

Among some of the key indicators, Texas was No. 5 for highest total spending on incentives as a percent of GDP and No. 4 both for highest average growth in number of small businesses and longest average work week.

Position: Revenue and Receivables Accountant

Reports to: Vice President of Finance and Controller

#### Position Summary:

The Revenue Accountant will primarily be responsible for inputting revenue on a diverse set of set of ~3,000 oil and gas properties owned by three U.S. GAAP investment entities representing over \$300 million in assets under management. The Revenue Accountant will also be responsible for coordinating with personnel in the land department to maintain accurate revenue decks for each property and verifying the revenue interests of new properties appearing on check stubs. The overwhelming majority of the transactional volume for these entities' revenue will be entered via an upload portal that accepts Excel and .txt files; only a minor portion of revenue stubs will need to be manually keyed in. The Revenue Accountant will also be responsible for tracking collections of other non-trade receivables and current assets.

#### Responsibilities:

- I. Revenue accounting:
  - Entry of revenue stubs into general ledger system
  - Developing and maintaining relationships with counterparts at E&P operators to help resolve accounting inquiries
  - c. Monitoring timeliness of receipts by operator and escalating outstanding balances to management
  - d. Preparing basic balance sheet account reconciliations on a monthly basis for trade and non-trade receivables and other current assets
  - e. Maintaining revenue decks
  - f. Notifying management of completeness of revenue accrual so month-end close may commence
  - g. Gathering supporting documentation for audit requests
  - h. Assist in the preparation of year-end accrual
- II. Internal controls:
  - a. Maintaining internal control documentation, specifically over cash receipts process
  - b. Ensuring integrity of accounting data through adherence to the company's internal controls
  - c. Gathering and maintaining evidence of the operating effectiveness of revenue-related ICOFR
- III. Other job-related duties, as assigned by supervisor
  - Would most likely include accounts payable tasks, on a temporary basis, when the payables accountant is out of the office

### July 2018

During the American Revolution, the legal separation of the Thirteen Colonies from Great Britain in 1776, actually occurred on July 2. Second Contential Congress voted to approve a resolution of independence that had been proposed in June by Richard Henry Lee of Virginia declaring the United States independent from Great Britain rule. After voting for independence, Congress turned its attention to the Declaration of Independence, a statement explaining this decision, which had been prepared by a Committee of Five, with Thomas Jefferson as its principal author. Congress debated and revised the wording of the Declaration, finally approving it two days later, on July 4. A day earlier, John Adams had written to his wife Abigail:

"The second day of July 1776 will be the most memorable epoch in the history of America. I am apt to believe that it will be celebrated by succeeding generations as the great anniversary festival. It ought to be commemorated as the day of deliverance, by solemn acts of devotion to God Almighty. It ought to be solemnized with pomp and parade, with shows, games, sports, guns, bells, bonfires, and illuminations, from one end of this continent to the other, from this time forward forever more."

Adams's prediction was off by two days. From the outset, Americans celebrated independence on July 4, the date shown on the much-publicized Declaration of Independence, rather than on July 2, the date the resolution of independence was approved in a closed session of Congress.

The ADDC Convention will soon be here in Evansville, Indiana, September 17 – 21, 2019, get your registrations in as soon as you can!!! ## Peach Salad with Grilled Basil Chicken and White Balsamic-Honey Vinaigrette



### **INGREDIENTS**

### **Grilled Basil Chicken**

- 1 lb boneless skinless chicken breasts
- 3 Tbsp olive oil, plus more for brushing grill
- 1/3 cup slightly packed chopped fresh basil
- 2 cloves garlic, minced
- 1 Tbsp fresh lemon juice

  Selt and freshly ground block non

Salt and freshly ground black pepper

### Vinaigrette

- 1/3 cup olive oil
- 3 Tbsp white balsamic vinegar
- 1 Tbsp honey

- 1 tsp dijon mustard
- Salt and freshly ground black pepper

### Salad

- 10 oz Spring Mix lettuce
- 1 lb peaches, sliced (about 3 small)
- 2 ears corn , husked & kernels cut from cob
- 1/2 cup chopped pecans, toasted
- 1/2 small red onion, sliced thin (about 3/4 cup), rinse under water to remove harsh bite
   4 oz Goat cheese, crumbled

### **INSTRUCTIONS**

### For the chicken:

- In a small mixing bowl whisk together olive oil, basil, garlic, and lemon juice and season with salt and pepper (about 1/2 tsp of each). Using the back of a spoon, press basil against sides and bottom of bowl (to help extract flavor from basil). Place chicken in a resealable bag and pound thicker parts of chicken to even thickness with a meat mallet, then pour basil mixture over chicken and evenly distribute basil over chicken. Seal bag while pressing excess air out, rub marinade over chicken and transfer to refrigerator and marinate 2 5 hours.
- Preheat a grill to 425 450 degrees over medium high heat. Brush grill grates lightly with olive oil then place chicken on grill. Grill until cooked through, rotating once halfway through cooking, about 4 - 5 minutes per side (chicken should register 165 degrees in center of chicken on an instant read thermometer). Transfer to a cutting board and let rest 10 minutes then slice into strips or dice into cubes.

### For the vinaigrette:

• Whisk together all ingredients until well blended and season with salt and pepper to taste. Store in refrigerator until ready to use, stir again before pouring over salad.

### For the salad:

• In a large salad bowl gently toss together lettuce, peaches, corn, pecans, onions, and grilled chicken. Sprinkle goat cheese over top and drizzle with vinaigrette. Serve immediately after adding dressing.
